1	Board membership
	After welcoming those present, VB said she had two resignations to announce: those of Dee Walker and Mark Lacey. She read some comments from their resignation letters. Board colleagues expressed their thanks to both these Trustees. In their different ways they contributed to challenging the way we do things, which can only be constructive. The Chair then introduced Daphne Simmons, as a potential new Trustee to colleague. DS described her professional background in working with communities, training and supporting volunteers and generally supporting the voluntary sector, before explaining why she wanted to join the Board of HWS and what she felt she could offer. Several Trustees had worked with her in the past and she was unanimously elected to the Board with immediate effect (20 Nov 2023). 2	Election of Trustees			
	MK had been elected to the Board at a previous session of the Board, but this is the first Public Board meeting to confirm it. She told colleagues of her experience and why she was keen to join HWS. Membership of the Board formally approved.

	Brian was thanked for creating such a simple way of recording potential conflicts of interest. Trustees confirmed they had completed the register. There were no relevant declarations relating to today's agenda.			
4	Guest speaker: The Local Care Transformation Programme			
	Penny Bason (Head of Joint Partnerships, STW ICS and Shropshire Council Health, Wellbeing and Prevention Directorate) was welcomed. She shared some slides about the progress made with this major ICS strategic change programme, managed (for Shropshire) by ShIPP (Shropshire Integrated Place Partnership) together with the Council's One Shropshire. Penny responded to the many and varied questions from Board members within an animated discussion. These included: • Health inequalities at a local level • Local, affordable housing for care workers (and specialist housing for people with disabilities) • Examples (such as Bishop's Castle, Ludlow, Highley) where inter-agency collaboration and public enthusiasm and commitment are already making a difference It was agreed some major challenges remain around the County's finances as the			
	cultures of the different organisations. Penny described the shift to a 'how can we help?' being promoted for all organisations: Ask – Assist – Act.			

5	Minutes of previous meeting and matters arising				
	The minutes were confirmed as a correct record. There were no matters arising.				
6	Chair's report				
	The Chair reported on a couple of recent events.				
	 She attended an online briefing session last week by SaTH on their most recent CQC report. The progress made since the inspection in 2020, when the Trust was put in special measures has been remarkably good. The only service that remains 'inadequate' is urgent and emergency care. However the other good news, that the Hospital Transformation Programme has been formally approved by the Dept of Health, and the capital monies released, will eventually have a significant impact on the way these services are delivered. Also the CQC is doing a formal assessment of Shropshire Council week 				
	 commencing 3rd June. There was an interesting announcement last week that SaTH and ShropComm are seeking to appoint a Chair in Common 				
7	Finance report – 2023-24				
	HWS set a deficit budget for 2023/24 but we have clawed all of that back and ended the year £4,500 in surplus. The Board thanked Lynn and the staff at The Hollies for a relatively smooth transfer of responsibilities for our financial management. We look to benefit by further significant savings from this change. There were no questions and the end of year accounts were approved.				
8	The Forward Plan 2024-25				
	LC described this year's approach, which seeks to build on previous priorities agreed by HWS, Shropshire Health and Wellbeing Board and the Integrated Care System in addition to some new areas that HW England is promoting. For this year the team has considered the published priorities of the local system as well as those of HWE, and then we had discussions with our board and volunteers. Together they indicate nine core areas of work, which can be grouped into five over-arching themes: Access; Inequalities; Prevention; Quality; Carers.				
	She emphasised the very real difficulties caused by the restricted HW budget, difficulties in engaging with HW Telford & Wrekin to undertake joint work and the 'churn' occasioned by staff changes at the Integrated Care Board.				
	The Board considered that these proposals set a reasonable and achievable agenda for the next 10 months
